

# “Alleged Coup and Behind the Scenes Hasina’s Assassination Mission 24”

**Dr. Md Anamul Hoque-** Just as a crow wings a peacock, it does not become a peacock, so a treasonous-terrorist attack never becomes a coup d’état. The term “people’s upheaval” was coined in Bangladesh in 1969. The mass upheaval or mass movement of 1969 is considered a milestone in the history of independence and the formation of the Bangladesh state – a once-in-a-lifetime event for any nation. “The main goal and ideology of the people’s coup is the state, society and politics” none of these elements are present or were not in the alleged people’s coup of 2024. So what was said in this movement of students??

If we analyze the context or background of the movement, it will be seen that the student movement was moving forward with a mere “job quota”. Almost all of us declared solidarity with the students and kept pressing the government and the government was forced to accept. Still why the movement did not stop or stopped?
